- I acknowledge that my paper has not been submitted* elsewhere for publication or published elsewhere. *Submission to the 2012 Edition of JALTA is the only exception.
- I acknowledge that the paper submitted has not been presented at the ALTA Annual Conference as a result of an invitation by the Conference Organisers nor will it be presented at a plenary session of the Conference.
- I acknowledge that I am not and will not be on the Selection Committee for these awards.
- I acknowledge that should I win and my paper is subsequently published elsewhere, I will acknowledge receipt of the award in the paper.
- My citation and text are according to the latest version of the Melbourne University Law Review, *Australian Guide to Legal Citation 3rd Edition*.

4. EVALUATION

The Selection Committee will evaluate papers on the following criteria:

- (a)** Significance and relevance of paper to Conference theme (This criterion is not applicable to the Legal Education Award);
- (b)** Choice of topic and analysis of issues;
- (c)** Quality of originality and research;
- (d)** Relationship to literature and theory;
- (e)** Coherence of argument and structure;
- (f)** Clarity of conclusions;
- (g)** Writing style and referencing
